 - The SAFE Cycle 2 funding is designed to help LEAs meet the required safety standards. If an LEA has already met the required safety standards, the funding may be used for other statutory school safety requirements and allowable expenses as outlined in Texas Education Code, §48.115. **The grant application will open on March 28, 2024, in the TEA eGrants system. The application will remain open for 45 days and will close on May 13, 2024.**
