The purpose of this correspondence is to notify the Crane Independent School District (ISD) of the correction of noncompliance identified in the Cyclical Desk Review.

- Transition: Measurable postsecondary goal

Subsequently, the local education agency (LEA) was required to submit documentation to the Texas Education Agency (TEA) verifying correction for the abovementioned noncompliance.
