Subject: Notification of Correction of Noncompliance

Dear Mr. Hawkins:

The purpose of this correspondence is to notify George Gervin Academy of the correction of noncompliance identified in the Cyclical Desk Review.

On April 29, 2022, George Gervin Academy received notification of noncompliance and was required to correct the following identified noncompliance within one calendar year:

- IEP Development: Present Levels of Academic Achievement and Functional Performance, and Measurable Annual Goals in accordance with 34 CFR §300.320(a)(1); 34 CFR §300.320(a)(2)(i).
- IEP Contents: Continuum of alternative placements and Evidence of Positive Behavior Supports in the case of a child whose behavior impedes their own learning or that of others in accordance with 34 CFR §300.115(a) and 34 CFR §300.320(a)(2)(i).
- Child Find/FAPE: Evaluations and Reevaluations, Consideration of student's need for modifications, related services and/or Annual Goals to support access to the General Education Curriculum; As well as REEDs completed by an IEP team and other qualified professionals and Evaluation Procedures in accordance with 34 CFR §300.305(a)(2)(iii)(B); 34 CFR §300.305(a)(2)(ii); 34 CFR §300.305(a)(2)(iv); and 34 CFR §300.305(a).
- State Assessment: Evidence of Intensive Plans of Instruction in accordance with TEC §28.0213
- IEP Implementation: Accessibility of IEPs to teachers and other service providers in accordance with CFR §300.323(d) and TAC §89.1075(c)(1)

- Transition: Initial Transition Date, Coordinated Set of Activities related to Transition and Transfer of Rights in accordance with 19 TAC §89.1055(j)(2), 34 CFR §300.43, TEA §29.011, 34 CFR §300.520, and TEC §29.0111
- Child Find/Evaluation/FAPE Policy in accordance with TAC §74.28(m) 34 CFR §300.43
- IEP Implementation Policy in accordance with TAC §74.28(k)(4)

On June 2, 2023, George Gervin Academy received notification of continuing noncompliance status when it did not complete its corrective action plan within one calendar year.

George Gervin Academy's corrective action plan for the identified noncompliance outlined steps for correcting each area of noncompliance. Subsequently, George Gervin Academy was required to submit documentation to the Texas Education Agency (TEA) verifying correction for the above-mentioned areas of noncompliance. The documentation submitted by George Gervin Academy indicated that each area of noncompliance has been addressed, and the noncompliance has been corrected. Therefore, no further action on this issue is required at this time.
