At Sterling High School in GCCISD, we house the Career Academy for Future Educators which is part of our school-within-a-school PTECH and follows the National Career Academy Coalition's National Standards of Practice. The Grow Your Own grant will provide teacher stipends for two education and training teachers and cover CTSO dues and competition fees for current chapters of TAFE and FCCLA. Students have the opportunity to earn an associates degree in Teaching through our partnering IHE, Lee College. The 2024-25 school year will be the first year we implement dual credit into Instructional Practices with EDUC 1301 and the following year 2025-26 we will implement dual credit into Practicum in Education and Training with EDUC 2301. Goose Creek CISD human resources department has committed to the graduating seniors in the Education and Training pathway that when they finish their degree in teaching, we will guarantee them an interview in the district. Students are encouraged to obtain their Education Aide certificate and work as an aide in the district while they are pursuing their degree in teaching. Students are also encouraged to apply for the BAER2 (Baytown Area Education Recruitment and Retention) program and scholarship which is a partnership between Goose Creek CISD, Lee College & University of Houston Clear Lake for students who are pursuing a degree in education. Students who receive the scholarship are provided with opportunities for employment and experiential learning.

The Director of Federal Programs, grant manager, is a central office administrator whose duties include managing grants for the district. The Director of Federal Programs, CTE Director and CTE Specialist will work together to implement and manage all aspects of the grant. The campus CTE Specialist oversees the Career Academy for Future Educators. The CTE Specialist also works with the education and training teachers and students to provide support and help with implementation of the grant as well as monitor student achievement and PTECH outcomes-based measures. The academy/PTECH assistant principal and counselor monitor student progress through the 4-year plan, student achievement, behavior and attendance. We have 2 teachers that teach education and training courses, one that qualifies to teach dual credit and another that teaches the high school courses. Each teacher is an advisor for TAFE and one of them is also the advisor for FCCLA.

Strategies: promote non-traditional enrollment by use of photos in high school options booklet, Future Teacher Signing Day, mock interviews, internships, educational aide certifications, associate degree in teaching/dual credit offerings
Goal 2: 10% of cohort 2026 Career Academy for Future Educators (1st PTECH cohort) will earn an associates degree in teaching.
Strategies: counselor works with students on 4 year plans, students given opportunities to take dual credit courses during the summer, TSIA preparation starting as early as before freshmen year
Goal 3: 100% of Career Academy for Future Educators students who meet qualifications for Educational Aide Certification will complete certification by August 2026.
Qualifications: 18 years old, must pass 2 or more courses for 3 or more credits in Teaching and Training program of study, must have SSN and valid ID to get fingerprinted.

As our program is part of the CCRSM network, we track all outcomes-based measures outlined in the PTECH blueprint. We also track similar data outlined in the National Career Academy Coalition's National Standards of Practice. As a district CTE team, we track college readiness, EOC data, dual credit, IBC data and CTSSO participation data.

One non-dual credit E&T teacher stipend of \$5,500, divided evenly into 2 disbursements in spring 2025 and spring 2026. One dual credit E&T teacher stipend of \$11,000, divided evenly into 2 disbursements in spring 2025 and spring 2026. In previous GYO cycles, we have received funds and have been able to retain E&T teachers with the use of this stipend.

We currently have 2 education and training teachers that are interested and eligible to participate in the program and receive stipends. Both teachers have experience teaching courses in the teaching and training pathway. Our dual credit instructor will be teaching Instructional Practices for dual credit for the first time in the 24-25 school year. Both instructors are active sponsors for TAFE and FCCLA and lead students to success in competitive events. Over the last several years, we have had students travel to nationals in TAFE/Educators Rising events and we always have a large group of students participating at state competitions for both TAFE and FCCLA. We currently have several field site teachers who participate in our program. This is an area where we could see improvement with the ability to give stipends for those who are very actively engaged in supporting our student interns. There is currently a lot of diversity in the experience students have in their internships.

Program Implementation Support: Describe the types of support that will be provided to Education and Training teacher stipend recipients to ensure successful implementation of the curriculum and program. The definition of successful programming should align with the major goals/objectives of the program.

Teachers are provided with ongoing professional development opportunities provided by the district to strengthen their abilities in the classroom. As part of the NCAC National Standards of Practice, teachers work in interdisciplinary PLCs to incorporate the education career theme into core curriculum. CTE and core teachers collaborate to create authentic projects and activities for students to help connect their learning with real-world problems. Both teachers have been trained in Project Based Learning and continue to receive implementation support from the CTE staff. Our IHE provides professional development to all adjunct faculty and the IHE Education department head is part of our advisory board to support teachers with curriculum implementation.
