This grant will allow the Career and Technical Education Department to recruit, train and retain additional educators to teach dual credit Education & Training courses in a school district that is short CTE teachers. We seek to recruit and retain minority educators for our teacher pipeline acquainted with the challenges facing underrepresented student populations. The district is 61.5% minority. Additionally, 51.3% of the student population is at risk while 52.4% is economically-disadvantaged. North East ISD has 31 schools that are Title One. Meanwhile, the district has about 120 teaching vacancies. Nationwide, 225,000 vacancies are expected by 2025 while Texas school districts hired 15,000 uncertified teachers last year to fill vacancies, according to the Texas Association of School Boards. Plus, the subject areas in which there is a shortage includes Career and Technical Education, according to the Texas Education Agency. The educators that we seek will serve as role models to students who will see successful minority educators and pursue their own educational and career aspirations.

#### B. Qualifications and Experience for Key Personnel

The grant manager will be the longtime Senior Director for the Career and Technical Education Department as well as the department's Program. Coordinator. Both will ensure that marketing, recruitment, teacher quality and grant requirements are followed to ensure 100% success. The Senior Director reports to the Chief Academic Officer who also will be requesting updates on the progress of this program. We expect the CTE dual credit teachers that we expect to recruit for this program will remain at their current campuses. Therefore, the principals of Roosevelt, Churchill, and MacArthur High School - home of the Early College High School magnet program - are veteran educators whose support and input to previous CTE projects have proven valuable. The college/career counselors at these high schools continuously provide input to CTE programs and suggest means to recruit additional students to CTE programs. These

	counseiors will be instrumental in the success of this grant program.

We have several goals: 1) Recruit and retain qualified teachers by identifying and recruiting teachers with the necessary qualifications to teach dual credit courses and have demonstrated commitment to teaching diverse student populations. 2) Increase male student enrollment from underrepresented populations by developing recruitment strategies that target male students from underrepresented populations to dual credit CTE courses. We will also collaborate with high school counselors and principals to promote the benefits of dual credit CTE courses. 3) Increase student enrollment in dual credit CTE courses by developing marketing materials and outreach campaigns to increase awareness of dual credit CTE courses among rising high school students. Research has shown that a teaching force that reflects community demographics has a positive impact on minority students, attendance, scores. Nurturing the teacher pipeline will reap rewards.

The stipend provided by this grant will attract qualified CTE educators to the program with the incentive of collaborating with San Antonio College, CTE's dual credit granting institute of higher education. Additionally, the CTE department and IHE will offer training materials required by the educator. Male students will be recruited through targeted outreach as well as through informational sessions provided by campus career counselors with an emphasis on the financial advantage of enrolling in dual credit courses while in high school.

Additionally, we will evaluate the success of the program by tracking retention rates among participating educators. We will conduct surveys to assess job satisfaction and monitor students in dual credit courses.

The CTE recruitment strategy for the Education & Training dual credit courses includes seeking qualified educators from within the district who fulfill the job requirements. The district-wide approach to hiring educators includes attending job fairs and scouting by the Human Resources department New Talent and Evaluations Department.

The district's strategy to retain teachers includes offering professional development and opportunities to seek additional training in their subject area. The educators that we propose to recruit for this program come from within the district so the end of the grant cycle will not prompt their departure. However, a similar future grant opportunity will allow us to apply again, which, in addition to partnering with local businesses and organizations, and funds from the local budget, will help enhance future CTE efforts.

#### D. Performance and Evaluation Measures

Our focus on dual credit student success requires performance measures that accurately tracks progress. We have established the following performance measures: 1) Dual Credit Student Enrollment: We will monitor the number of students enrolled in our dual credit Education & Training program as well as their engagement with valuable opportunities for academic advancement. 2) Grades: We will closely monitor the grades of dual credit students to evaluate their academic progress and proficiency and offer tutoring or counseling when students average below a "B". 3) Attendance: We will ensure that students attend consistently. More than five absences in a grading period will require counseling and intervention to determine eliminate the reason for absences. The tool that we will use is the Texas Education Agency (TEA) Early College High School (ECHS) benchmarks and outcomes. Additionally, we will collaborate closely with teachers at the early college high school and with teachers at the dual credit classes at the two other high schools to collect and analyze data aligned with TEA ECHS benchmarks. This will include 1) fall and spring enrollment data, 2) student demographic data reports from our SIS (SPELL THIS OUT), 3) student academic grades, 4) continuous communication with our dual credit IHE, teachers, counselors, and campus principals.

Teachers who teach dual credit Education & Training spend 50+ additional hours a year completing dual credit professional development, attending department meetings, preparing lessons plans, grading and student intervention. This stipend will validate for these educators their focus and passion in this high-needs area. The stipend will be \$11,000 for each participating educator totaling \$33,000 over the two-year grant cycle. The additional funding of \$2,000 for earmarked for high schools will be for our new dual credit teacher at Churchill High School as the upcoming 2024/2025 school year will be the first year of dual credit courses there.

We will seek district educators who have master's degrees and the qualifying hours to teach dual credit. We will start by reviewing CTE teaching staff then inviting those that qualify to consider participating in this program. Meanwhile, we will survey campus principals to determine whether they recommend staff that meet the criteria and relay the invitation to contact the CTE department. We will review a candidate's student data to determine achievement levels, then review their personal evaluating ratings and the relationship between educator and student.

Also, CTE leadership and educators will determine whether the current curriculum is delivering results ideal for student success as well as discuss developing industry trends and strategies. The grant program director will conduct walk-throughs then discussions with both educator, principal and career counselors to determine progress of the program.




