The program to be implemented is provide support for our year long resident (YLR) program by paying the salary of district personnel that implements the YLR program. Our overall mission is to prepare YLR to be day one ready and have higher engagement with their students. The program will address the mission and needs by providing the necessary funding and allowing us to work with Stephen F. Austin State University to form a partnership for residency and explore other avenues of sustainable staffing for YLR.

The program coordinator has been with the district for 6.5 years. She is the Assistant Director of Human Resources and holds a Masters degree in Education from Stephen F. Austin State University. Angela has spearheaded the development and continuation of YLR in Bryan ISD. She has worked with Region 6, TAMU, and SHSU to pilot a sustainable method for staffing EC-6 YLRs. The program EPP is an Associate Professor of Education Studies at Stephen F. Austin State University. She has a PhD in Instruction and Curriculum from Texas Tech University and is a Certified teacher and Certified Field Supervisor. Technical Assistance will be provided by the Region 6 technical assistance provider to help us develop a sustainable staffing method.

Instructional and talent developmental needs of the district includes a sustainable program to support YLR. Teacher residencies will be made sustainable through a hybrid release time model that is unique to the district. We also would like to explore other models for sustainable staffing. (a) Vacancies in our district last year included 258 teaching positions. (b) Other instructional needs are paraprofessionals, small group instruction and tutoring residents could help us address this issue by helping with these. (c) Paid teacher residencies tend to remain with the district after graduation. Since 2019 Bryan ISD had had 97 YLRs. 69 are still employed with the district. 8 did not complete their residency. 9, who are no longer with the district, taught for 1 or more years after residency. Only 11, out of 89 who completed their residency, did not remain in the district after their residency ended.

The district is committed to self-fund all the SPED/BIL residents we can attract from our EPPs. (1) During the year-long design process, BISD will work with Region 6 as our Technical Assistance Provider and SFASU to design a sustainable staffing process for YLR. (2) During implementation support, BISD work along side SFASU to recruit, place and support at least 2 YLRs from SFASU. (a) The BISD YLR program coordinator will be spearheading YLR. (b) She is responsible for recruiting and onboarding new employees. This works hand in hand with YLR. (c) YLR is currently approximately 20% of her responsibilities. We will track and maintain evidence of her time in the number of residents recruited and placed within the district, site visits and governance meetings in partnership with the EPP. (d) When the grant ends, BISD is committed to continue having YLRs and the YLR program coordinator will continue to support them in the same capacity in addition to her other duties.

BISD has had 2 partners in YLR. In 2023-2024, we worked with Sam Houston State University and Texas A&M University. (a) We have been working with SHSU since 2020 to place YLRs and TAMU since 2019 to place YLRs. Both EPPs were chosen due to our geographical proximity to the EPP. (b) We have placed 97 YLRs since 2019 from SHSU and TAMU. Now that TAMU is no longer vetted, YLRs from TAMU are district funded.

How often do you meet with your EPP partners to review this data? As a partnership, how do you manage follow-up and response to data? BISD is committed to shared governance of YLR with SFASU. (a) Currently with our other EPPs, governance meetings are conducted quarterly. (b) Our EPP sets the agenda, with LEA input, about YLR progress. During these meetings, we address concerns with data and how to follow up on the concerns. (c) We plan to implement a similar plan with SFASU. (d) BISD and SFASU have had several in person and zoom meetings previously to explore a partnership. The proximity of SFASU's satellite campus at RELIS make this an ideal partnership to do the work toward sustainable staffing together.
