The grant funds will be used to support the district's teacher residency program, which ultimately has a positive effect on our students in the classroom. The mission of the district is to be a place of high standards where each student is prepared for success in careers, relationships, and life. In order to provide this service to students, we must ensure a pipeline of effective teachers to provide quality education.

The district personnel that oversees strategic staffing is an existing position. Experience for this position includes ten years of school administrative experience, three years of experience with strategic staffing in the district, and training in teaching models and implementation of the program from the technical assistance provider and institute of higher education. The position entails coordinating training for residents, mentors, and administrators, collaborating with the institute of higher education to place and support residents, and ensuring successful program implementation.

The goals of the district strategic staffing program are to coordinate with the institute of higher education, provide living stipends for resident teachers, and ensure a teacher pipeline for our classrooms. Existing relationships and lines of communication will be used to continue communication with the institute of higher education to place residents each school year. Residents and mentors receive training in the district. Existing collaboration with the technical assistance provider will be continued to provide this training; regular observations of residents and mentors; and regular interviews with residents, mentors, and administrators. The program will be evaluated each year for strengths and weaknesses, and areas of weakness will be addressed to create a better program.

The district historically has at least five vacancies each year due to turnover that must be filled. These openings typically include core content areas. In addition to vacancies, the district needs to ensure that all teachers are certified in their areas of assignment. Residencies allow us to train teachers, in collaboration with the institute of higher education, for specific needs in the district. Resident teachers also allow us to more adequately cover substitute teacher needs and paraprofessional needs for struggling students. Paid teacher residencies are part of our overall staffing plan and help the district to ensure a fit between residents and upcoming openings. Filling upcoming openings allows us to decrease turnover over the next five years and provide high quality education to our students with existing teachers and residents that become full-time, certified teachers.

The district will continue the work that was started in the 2021-22 school year and improve upon the design process that was put in place at that time. The district also has experience with implementation of paid residencies, and that process will also be continued and improved. The Director of School Programs leads the work on paid residencies and has done so since 2021-22. The role fits with the overall administrative talent management plan that is implemented with the superintendent and campus administrators to plan in advance for vacancies and find the right people to fill the openings. The Director of School Programs can track time spent on talent management and the residency program using a spreadsheet. The role will continue when the grant ends, and funding will have to be supported by the district at that time.

The district meets regularly with the institute of higher education in governance meetings to review data and the program and work collaboratively to make decisions about the best resident and mentor support. We meet at least four times per year. The Director of School Programs is in regular communication with our site coordinator to make sure that the district responds to desired changes based on data and governance recommendations. The relationships among the site coordinator, the technical assistance provider, and the district have been instrumental in ensuring positive implementation of the residency program and successful placement of residents. Each entity is supportive of the others, and we work in the best interests of our teachers and students.

Evidence of strong communication with our site coordinator and technical assistance provider is shown in email, phone, and in-person collaboration. Shared norms include a guide of parameters for teacher residents as co-teachers, a model of gradual release of responsibility, a communication guide, training collaboration, shared design work, and common objectives and goals. When challenges arise, the district works closely with the cooperating teachers and site coordinator to make sure there is a clear plan of action and relevant individuals are included as needed. This includes support with substitute responsibilities.

The data that drives our work with strategic staffing is a continued need for a teacher pipeline to ensure quality teachers for the openings that we consistently experience each school year. Our student progress data is also used to determine areas in which improved staffing is needed. Instructional needs are different each year, depending on which teachers leave the district and which classes are needed based on class sizes and student credit needs. Our goals for the next design year are to assess district needs and strategize to fill the needs with resident teachers. Our goals for the next implementation year are to place the residents and support the residents and their mentor teachers, in collaboration with the institute of higher education and technical assistance provider, to help the residents grow in preparation to become full-time teachers that provide a quality education to our students.
