

## Summary of Program

Our district is applying for Focus Area 2 (work-based learning) and plans to offer a student internship with the Career Preparation I course, open to students from Brooks County ISD, Freer ISD, and Premont ISD. Premont ISD is a small, rural district in South Texas. Premont ISD is a district partner of the Rural Schools Innovation Zone (RSIZ). The RSIZ is a first-of-its-kind partnership made up of three school districts and two institutions of higher education (dual credit providers) in South Texas. The RSIZ is a nonprofit organization designed as a sustainable collaborative between Brooks County ISD, Freer ISD, and Premont ISD with a mission of providing rural students high-quality opportunities for postsecondary success. Our primary vision and goal is to reinvent the rural education experience by providing students in all three of our school districts more high-quality opportunities through shared partnership. Students in the RSIZ may attend academies at any of our district campuses, including the Ignite Technical Institute Career and Technical Academy (welding, building trades, electrical, heavy equipment) at Falfurrias High School, the Next Generation Medical Academy (health science/nursing science) at Freer High School, the Grow Your Own Educator (education and training/teaching and learning) and the STEM Discovery Zone Academies (STEM/engineering) at Premont Collegiate High School. Our proposed summer program will provide summer work-based learning experiences to students from across the RSIZ. Specifically, our proposed summer program will support summer internships for students in the STEM Discovery Zone and Grow Your Own Educator Academies (each CTE academy is housed at Premont Collegiate High School and open to enrollment to any RSIZ student). Engineering students from the STEM Discovery Zone will be placed in summer internships with several current engineering firms who are business and industry partners for the district. The engineering firms are located in Corpus Christi. Grow Your Own Educator Academy students will serve as interns for Premont ISD over the summer. Providing authentic, real-world experiences to our students supports the mission and vision of the RSIZ and will help to prepare our students for the workforce. Alongside the internships, students will earn course credit in Career Preparation I (PEIMS Service ID 12701300). We strive to serve 20 interns as part of the summer program (we will strive to enroll 10 students per academy). The program will last five weeks with the first week serving as an internship bootcamp to help students be aware of, and develop, employability skills while addressing specific TEKS associated with Career Preparation I. Weeks 2-5 will be on-the-job training/internships for the students. The engineering students will travel daily to Corpus Christi to work at the engineering firms while Grow Your Own students will travel to Premont to learn about school and district operations and serve as classroom aides/tutors for our summer school program.

**Goals, Objectives, and Strategies**

We will offer a work-based learning program (Focus Area 2) centered on Career Preparation I and paid student internships. Premont ISD will support students from Premont ISD, Freer ISD and Brooks County ISD by placing students into summer internships with Corpus Christi-based engineering firms and at Premont ISD. By August 31, 2022, 20 students will be placed into internships at either an engineering firm or Premont ISD. All 20 students (100%) will earn course credit in Career Preparation I (PEIMS Service ID 12701300). All 20 interns (100%) will receive favorable marks from their internship supervisor/sponsor. We will meet these goals and objectives by ensuring our leadership is equipped to support the CTE Summer Internship program. We will utilize our website and social media pages, along with RSIZ website and social media pages, to spread awareness about the objective, mission, and activities. We will ensure students are enrolled in the program in time to plan for summer activities by beginning recruitment and enrollment as soon as the grant award is announced (April). We will target recruiting/enrolling 11th-12th grade students from Falfurrias HS (Brooks County ISD), Freer HS (Freer ISD), and Premont Collegiate HS (Premont ISD) who have taken at least two CTE courses related to Engineering or Education and Training. We will ensure student success in the Career Preparation I course and internship by equipping the CTE teachers leading the course with instructional materials and supplies to provide instruction. The teachers will be supported by the Premont ISD administrators to ensure students master the content. The executive director of the RSIZ will also provide support for the program.

Our Summer 2022 Internship Program will be focused on student outcomes and evaluated based on several performance measures and data points. We will collect data on the demographics of students who enroll in, participate in, and complete the program, including grade level, race/ethnicity, and economically disadvantaged status, as well as whether they have been identified as in need of special education services. We will utilize other data collected for TSDS PEIMS to provide analysis numbers for district leadership teams, our school boards, and TEA grant reporting requirements. Our goal is to have all students (20) (100%) of students who participate in the program to receive course credit for Career Preparation I. We seek for all 20 (100%) of students to fulfill their internship responsibilities. Another goal is to have all 20 students (100%) of the students receive positive feedback from internship providers/sponsors regarding their on-the-job performance. A final goal is to receive indication from all internship providers/sponsors (100%) that they would be willing to host students again in future iterations of the program. We will provide additional services to students who need additional support, such as tutoring and mentoring sessions with the course teacher. We must provide wraparound services like these in order to provide an equitable setting for all students, the majority of whom are from economically disadvantaged households. Data on all of these services will be collected by the teachers and the Rural Schools Innovation Zone Executive Director to evaluate student need and intervention. During the first week of the program, there will be formative quizzes and summative exams delivered. The training plans will be evaluated (at a minimum) at the beginning and end of the internships. These assessments will be used to guide instruction, determine intervention needs, and evaluate TEKS mastery for course credit. To measure student learning objectives and outcomes in the internship experience, we will administer a feedback tool with our business partners regarding our students behavior and performance during the internship to gather and analyze this data. The data will be both qualitative and quantitative and will provide insight on whether our goals, learning objectives, and student outcomes were met successfully.

If Premont ISD receives the grant award, our school district will utilize grant funding to offer a summer internship program for engineering students and education and training students. The program will be available to students from Falfurrias HS, Freer HS, and Premont Collegiate HS who are members of the STEM Discovery Zone Academy or the Grow Your Own Educator Academy. Over the past three years our district, and partner districts (Brooks County ISD, Premont ISD), have placed a greater emphasis on providing work-based learning opportunities for our students. This grant program will help us support 20 students by providing meaningful and impactful summer employment opportunities (internships) for our learners. Through this grant funding we will be able to serve additional students who may not be able to participate in Career Preparation I during the traditional school year due to other scheduling constraints and other obligations and commitments. This grant program will help our district provide additional capstone work-based learning experiences to 20 students. We believe that we will be able to utilize data and outcomes from this program to demonstrate the need and return on investment for future funding to our school boards and communities. Local funds provide coursework within each of these CTE programs during the school year but do not currently provide summer program opportunities.

Grant funding will be utilized to support payment for interns at the engineering firms and at the school district. Students will earn a stipend of \$1,250 for their internship, which will average to \$12.50 per hour over the course of their 100 hour internship experience.

Transportation is a major component of the budget. Our districts are in a remote part of South Texas and we will be transporting some students/interns from each school district to Premont/Corpus Christi each day for their internships. We will utilize district assets and our district's transportation service to transport students to and from the school and to and from internship sites.

A small portion of the budget has been allocated to procure instructional materials and project-based learning supplies associated with the Career Preparation I course.

Extra duty pay for the teachers, support staff, and internship supervisors has been allocated in the budget. We have also allocated funding to pay a staff member to ride with interns to and from the Corpus Christi engineering internships. This staff member is necessary to comply with internal district policy.

Funding from the 2021-2022 CTE Summer Grant will allow Freer ISD, and the Rural Schools Innovation Zone (Brooks County ISD, Freer ISD, Premont ISD), to offer a summer internship program which will support two specific academies, the Grow Your Own Educator Academy (Education and Training/Early Learning) and the STEM Discovery Zone Academy (STEM/Engineering). The summer internship program will last five weeks in total, including instruction in Career Preparation I. The first week will focus on preparing students for the workplace experiences during weeks 2 through 5. Students will work 100 hours during their internship experience. The internship program will directly support students enrolled in two programs of study: 1.) Early Learning, 2.) Engineering.

All internship positions will be paid experiences for our students. Internships are designed to provide students with real world experience and develop their resumes and deepen their skill sets. Premont ISD will serve as the internship provider for students in the Early Learning (Education and Training) program of study. The district aims to host 10 students for the experience. Students will intern for the school district by serving as classroom aides at the elementary school's summer program. At least two engineering firms in Corpus Christi will be internship providers for 10 students in the Engineering program of study. Specifically, International Consulting Engineers (ICE) and GPM Engineering, Inc. have previously hosted student interns and will host interns this summer.



**Instructions: Request for Amendment**

After the original application is approved and the grantee has received the Notice of Grant Award (NOGA), the grantee may need to make changes to the budget or the planned program. Most grantees are permitted to make some changes to the budget or program without notifying or getting approval from TEA. (Some grantees are required to notify and get approval from TEA for all changes to their budget or programs.) In other cases, however, the grantee is required to submit formal notice to TEA of the desire or intent to change the budget or program.

  - a. Complete the box in the upper right corner of the schedule by indicating the number of the amendment. The first amendment you submit for the grant is #1; if that amendment is approved, the next amendment becomes #2.
  - b. Ensure all applicant information is current and correct.
  - c. Ensure the authorized official information is current and correct. The authorized official must sign and date with the date that the amendment is being submitted.
2. Complete Appendix 1: Negotiation and Amendments
  - a. Choose the section you wish to amend from the drop down menu
  - b. Describe the changes you are making and the reason for the changes. Always work with the most recent negotiated or amended application. If you are requesting a revised budget, please include the budget attachments with your amendment.  
(example) Payroll 6300 —Reduce amount for extra-duty pay—Staff was able to complete training during regular working hours.
3. If you are requesting a budget change, complete the Request for Amendment budget page
  - a. In column A, enter the grand total for each class/object code in the most recently approved application or amendment.
  - b. In column B, enter the amount being deleted from each class/object code.
  - c. In column C, enter the amount being added to each class/object code.
  - d. Column D and the total direct cost line will automatically calculate your changes
4. If you are requesting a budget change, complete the Program Budget Summary page and the corresponding supporting budget page. For each class/object code on the budget summary, strike through the previously approved amount and enter the new budgeted amounts. The total budgeted cost for each class/object code on the budget summary must match the grand total for each supporting budget page.
5. Do not resubmit any attachments required in the original application.
