Grant funds will allow Merkel ISD to implement a work-based learning program (student internships) in partnership with Trent ISD. We will serve 20 students through the program, targeting enrollment of incoming 11th and 12th grade students from both Trent ISD and Merkel ISD. Merkel is a small town on the I-20 corridor approximately 18 miles west of Abilene. Business and industry is generally concentrated in Abilene so providing work-based learning experiences in Merkel can be a challenge. Summer CTE Grant funds will help us create opportunities which may not be available during the school year due to travel and time limitations. Merkel ISD's mission is to engage and empower students to meet challenges, demonstrate resilience, and achieve excellence. One of our top goals is to connect with the community and business partners to produce well rounded students who are marketable, informed, knowledgeable and prepared to enter the workforce. This summer program closely aligns to our mission and will provide a valuable experience that improves the college, career, and military readiness of our students.

Our proposed plan is to facilitate work-based learning opportunities (internships) and Project-Based Research coursework (PEIMS Service ID# 12701500) for 20 Merkel ISD and Trent ISD high school students. Students will be placed as interns at local businesses and Merkel ISD offices. While working at their internship placements, students will meet as a class one day per week to discuss employability skills and complete coursework for the Project-Based Research course. During the class, students will each choose an issue related to their internship placement's industry. The students will conduct research regarding their chosen issue and synthesize their findings and possible recommendations in a research paper and formal presentation.

Our goal is to expose students to a full-time work schedule as part of this experience. Throughout the program, interns will work as close to full-time as possible (32-40 hours a week). We believe this is an important aspect of the program to give students a glimpse into full time working conditions. Specific internship placements will be coordinated with business partners including Taylor Electric, Taylor Telecom, Elliott Air Conditioning, Visualutions, Kyle Paul Construction, the City of Merkel, Great State Apparel, and the Merkel ISD business, IT, and maintenance offices.

Grant funds will be utilized to plan and implement an internship program for students from Merkel ISD and Trent ISD. We aim to serve 20 students (targeting enrollment of incoming 11th-12th grade students) by coordinating and offering paid internships with Merkel ISD and several business partners (Taylor Electric, Taylor Telecom, Elliott Air Conditioning, Visualutions, Kyle Paul Construction, the City of Merkel, Great State Apparel). Our goal is for all 20 students (100%) to complete their internship placement (estimated to be 90-125 hours depending on the placement), pass and earn credit for Project-Based Research (PEIMS Service ID# 12701500), and demonstrate growth in employability skills (as measured by Internship Training Plans). A big-picture objective is to generate additional buy-in from our community to showcase our growing and improving Career and Technical Education programs. The summer internship program is a strategy which we believe will help us strengthen existing partnerships and develop new partnerships with businesses aligned to high-wage, in-demand career pathways in our region.

We will support the program by having a designated staff member (CTE Teacher) lead the course and internship facilitation. The teacher will work with the grant manager to liaise with the business partners to monitor students, identify student strengths, and troubleshoot any issues which arise. To prepare students for the internships, the staff members will mentor students regarding workplace expectations and employability skills. We will support the teacher by providing time for mentoring alongside the Project-Based Research class time. We will also contract with a technical assistance provider, CareerCraft, to help support the work-based learning aspect of the program (internship design) and data analysis/reporting to measure program effectiveness through Internship Readiness Assessments/ Training Plan development. Customized training plans will drive our determination of student outcomes and student growth in both technical and soft skills.

The Merkel ISD team will collect data on the demographics of students who enroll in, participate in, and complete the summer internship program, including grade level, race/ethnicity, economically disadvantaged status, as well as whether they have been identified as in need of special education services. We will also monitor and report to TEA: a list of business/industry partners offering work-based learning to students through this grant program, total and average hours worked by students in the program, total and average hourly earnings of students in the program, raining plans for each student in the program, partnership agreements for each business partner involved in the program, and a recognition of skills/growth for each student in the program. All applicable data will be reported in the PEIMS Fall Submission. Other data and artifacts (such as training plans) will be maintained locally and reported to TEA upon request. We will utilize other data collected for TSDS PEIMS to provide analysis numbers for district leadership and each of our school boards. Our goal is for all 20 students (100%) to complete their internship placement (estimated to be 90-125 hours depending on the placement), pass and earn credit for Project-Based Research (PEIMS Service ID# 12701500), and demonstrate a growth in employability skills (as measured by Internship Training Plans) by September 30, 2023. The teacher will utilize formative assessments to gauge the workplace readiness of students. Competency-based evaluations will be utilized as part of the training plan to record student ability and competency to perform various tasks while on the job. Customized internship training plans will drive our determination of student outcomes and student growth in both technical and soft skills over the course of the internship. The internship supervisors will meet weekly with each intern to identify areas of strength and areas where the intern requires additional support and coaching. Feedback will be gathered from internship supervisors at Taylor Electric, Taylor Telecom, Elliott Air Conditioning, Visualutions, Kyle Paul Construction, the City of Merkel, Great State Apparel, and Merkel ISD to evaluate student behavior and performance and identify areas for improvement. Data collected throughout the program will be harnessed to ultimately inform improvements in our CTE instruction and evaluate feasibility of offering student internships in the future.

Merkel ISD does not currently offer summer work-based learning opportunities. During the school year, work-based learning opportunities are largely offered through Career Preparation I and II courses. Grant funds will allow us the ppportunity to support students during the summer months. This program will help our district meet our goal of preparing students for college, a career, or the military. The student internships will allow students to explore potential careers and prepare for future careers by gaining employability skills. Should the program be successful, we hope to dentify future funding sources to sustainably offer a summer internship program.

Our proposed budget has been developed to maximize our impact in a short amount of time. Extra duty pay has been allocated to pay for a lead teacher (CTE teacher, who will teach Project-Based Research and lead internship acilitation), a grant manager (who will oversee grant activities and expenditures), and a payroll manager (who will be responsible for paying the students). Funds have been allocated to pay student interns a stipend of \$1,650 each (estimated average of \$15 per hour), as we anticipate interns working between 90-125 hours during the summer program. A small portion of the grant will be used to pay a contractor, CareerCraft, for assistance with internship design, data collection, analysis, and reporting associated with the grant. Funds have also been allocated for the procurement of shirts (t-shirts and/or polo shirts) for the interns to wear as a way of distinguishing them as interns at their worksites. Finally, a small amount of funds have been allocated to the Other Operating Costs budget category primarily to cover any small, miscellaneous expenses which arise during the program. We plan to use local funds and resources to provide student transportation. A small amount has been allocated for indirect costs to the district.

Through this grant funding, we will be able to serve students who may not be able to participate in work-based earning experiences during the traditional school year due to scheduling constraints and other obligations and commitments. Over 55% of our students are economically disadvantaged and 18% of our students receive special education services. This grant program is greatly needed to provide Merkel students with meaningful, high-quality student internships that they would not otherwise be able to have. It is important to our community that students work an internship schedule of 32-40 hours a week so that students can have the experience of working full time and all hat it requires. Merkel ISD is unable to offer this type of internship program during the school year because most students do not have availability in their schedules to work during the school day. Furthermore, most students have a full load of academic, elective and extracurricular commitments during the school year, so working during the year is difficult. This summer internship will allow students to solely focus on their internship placement, rather than competing priorities that may cause their academics to suffer.

Additionally, teacher availability is a limitation during the school year. Because we are a small, rural school district, bur teachers' schedules are full. We have limited staff and recently changed to a 4-day instructional week during the school year. This means our teachers have less time for instruction during the year and we must be efficient with the time available. The summer program will allow one of our CTE teachers to solely focus on the program and course, thus providing a more meaningful experience for students.

Students will also take Project-Based Research (PEIMS Service ID# 12701500) as a summer course. While working at their internship placements, students will meet as a class one day per week to discuss employability skills and complete coursework for the Project-Based Research course. During the class, students will each choose an issue related to their internship placement's industry. The students will conduct research regarding their chosen issue and synthesize their findings and possible recommendations in a research paper and formal presentation. Customized internship training plans will be utilized for each of the interns to create scaffolded learning opportunities throughout the program as well as to document competency on specified tasks. Specific internship placements will be coordinated with business partners including Taylor Electric, Taylor Telecom, Elliott Air Conditioning, Visualutions, Kyle Paul Construction, the City of Merkel, Great State Apparel, and the Merkel ISD business, IT, and maintenance offices. Internships will be aligned with high-wage, in-demand industries/career pathways in our region. Most internship opportunities will directly align with Merkel ISD's CTE programs, including Design and Multimedia Arts (Arts, AV Technology, and Communications); Early Learning (Education and Training); Teaching and Training (Education and Training); Carpentry (Architecture and Construction); and Family and Community Service (Human Services). We believe these experiences will help our students develop valuable employability skills and experience while gaining awareness of career possibilities for their lives. We believe these activities will also allow students to gain understanding of workplace responsibilities and settings necessary for longerm, successful employment.
