Summary of Program (Focus Area 1)

The overall mission of the Career and Technical Education (CTE) department is to empower all students with industry-specific opportunities that will allow them to further their post-secondary education or immediately pursue employment in the global workforce. CTE students will gain an understanding and knowledge of ethical behavior and workplace skills that are fundamental to career success. The CTE department is divided into thirteen career clusters. The Science, Technology, Engineering, and Mathematics (STEM) career cluster focuses on planning, managing, and providing scientific research and professional and technical services. These services include laboratory and testing, as well as research and development. First-year students of our CTE Cybersecurity program of study will learn about the occupations and educational opportunities related to the planning, implementation, upgrading, and monitoring of security measures for the protection of computer networks and information. In addition, students will explore responses to network security breaches and viruses, as well as the administration of network security measures.

Garland ISD Cybersecurity Summer Bridge program will allow second-year STEM students to build and perform complex network and penetration tests on multi-tiered hybrid domains. Upon completion of the program, students will be prepared to meet the challenges of today's advanced digital landscape.

The overall mission of the Career and Technical Education (CTE) department is to empower all students with industry-specific opportunities that will allow them to further their post-secondary education or immediately pursue employment in the global workforce. CTE students will gain an understanding and knowledge of ethical behaviors and workplace skills that are fundamental to career success. The CTE department is divided into thirteen career clusters. The Hospitality and Tourism career cluster focuses on the management, marketing, and operation of the following sectors:

- Restaurants
- Lodging
- Attractions
- Recreational events
- Other travel-related services

Hospitality students will acquire communication, time management, and customer service skills that align with today's industry standards. Program participants will also explore the history of the hospitality and tourism industry and examine the characteristics of successful industry trailblazers. In conjunction with the Texas Hotel and Lodging Association (THLA), we have designed The Garland ISD Hospitality Project to prepare students for entry-level positions in the Hospitality and Tourism industry. Students will be offered an immersive experience that includes career exploration and post-secondary education options in Lodging and Resort Management. Additionally, students will experience the industry first-hand, as guests and staff members in a three-day residential summer program. Students will tour the full-service hotel properties of select colleges, and attend seminars to learn more about personal branding, employment strategies, and career progression from professors and community business leaders.

Goals, Objectives, and Strategies (Focus Area 1)

Describe the major goals/objectives of the proposed program. What activities/strategies will be implemented to meet those goals/objectives?

The primary objective of the Garland ISD Cybersecurity Summer Bridge program is for students to obtain the necessary technical knowledge and abilities to meet the challenges of the modern cloud environment. Participants will learn to create a top-level domain complete with the following components: Network connectivity, main and backup domain controllers, and servers (exchange server for email traffic, SharePoint web server, file server and a print server). Students will also acquire hands-on experience in performing penetration and compliance tests on secure domains. Strategies to assist in achieving these goals will include:

- Designing and developing a comprehensive plan to create networks for small businesses
- Designing an organizational chart with each participant having at least one assigned role
- Scheduling regular progress update meetings with all stakeholders
- Establishing communication channels and expectations between all teams
- Recording and documenting all troubleshooting

Research has found that programs with structured and focused, well-organized activities foster engagement and facilitate high quality learning opportunities (Gerstenblith et al, 2005; Abreton, Goldsmith, & Sheldon, 2005). The program will provide intentional, research-based activities that are designed to align with state standards, and school day curriculum. Intentionality in activity design will ensure students are provided opportunities for enhanced learning in a safe, fun, and engaging environment.

Research-based academic instruction will reinforce and enhance school-day learning. Innovative best practices will include the integration of SMART goals (Specific, measurable, achievable, relevant, and timely). The impact will reflect academic instruction and engaging STEM activities that equip students to think critically.

Goals, Objectives, and Strategies (Focus Area 2)

The primary objective of the Garland ISD Hospitality Project is for students to experience the diverse knowledge of professionals in the hospitality industry through a work-based learning environment. Participants will learn about post-secondary education options that may enhance career growth within the hotel and lodging industry. Students will also acquire customer service skills and business practices and strategies that leading franchises attribute to their overall success.

Research-based enrichment activities will promote skill development and enhanced student engagement through service learning activities. Research has found that programs with structured and focused, well-organized activities foster engagement and facilitate high quality learning opportunities (Gerstenblith et al, 2005; Abreton, Goldsmith, & Sheldon, 2005). The program will provide intentional, research-based activities that are designed to align with state standards, and school day curriculum. Intentionality in activity design will ensure students are provided opportunities for enhanced learning in a safe, fun, and engaging environment.

Research-based academic instruction will reinforce and enhance school-day learning. Innovative best practices will include the integration of SMART goals (Specific, measurable, achievable, relevant, and timely). The impact will reflect academic instruction and engaging activities that equip students to select a career pathway in the hotel and lodging industry.

Performance and Evaluation Measures (Focus Area 1)

The Garland ISD Cybersecurity Summer Bridge program is designed to prepare students for industry-recognized credentials and employment through real-world application configurations. Experiential learning has been proven to provide students with a more efficient level of engagement and comfort than simply reading over course material. Notably, participants will gain and understanding of the Lenovo Rack Servers, which allow for the operation of multiple virtual machines in the student lab. Each server will provide students with hands-on experience in virtualization. Program curriculum will reinforce and expand upon the knowledge base gained in previous courses, giving second-year students a better understanding of material found in the CompTIA ITF+, A+, Cisco CCT, CompTIA N+, and AZURE certifications. Students will be evaluated on best cloud computing practices such as virtual switches, hypervisors, and virtual NICs. Other key evaluation concepts will include disaster recovery and device hardening to equip participants with the necessary combination of skills to ensure network resilience. Upon completion of the course, students will be able to earn one of the aforementioned certifications or college credit.

Garland ISD will develop a plan for sustainability that leverages funding from at least four sources. These four sources will include existing school budgets (General, state compensatory, and Title funds), business and community support funding, as well as additional grant funding. We will seek to find ways to allocate existing district budgets. We intend to work at communicating success of the Cybersecurity Program. Additionally, we recognize the level of funding provided by the grant is significant and continuation of the same level of service will require funding from a variety of sources. We intend to develop an on-going evaluation of the return on investment of each activity and service provided.

Performance and Evaluation Measures (Focus Area 2)

Performance will be measured by instructional and skills verification methods. Students will demonstrate customer service knowledge and skills through a capstone activity, which will allow each student to showcase their acquired skillset.

Participants obtaining the Texas Friendly Certificate will demonstrate how to manage and enhance the delivery of quality customer service that is unique to the hospitality industry. Performance tools will include a review that focuses on six hospitality habits necessary for the assurance of quality customer service:

- Making a positive and impactful impression
- Demonstrating knowledge of the occupation
- Establishing familiarity with the community
- Maintaining open communication
- Handling problems effectively
- Making a good, lasting impression

Complete participation will be required for students to obtain their certification.

Program Requirements

1a. Needs Assessment (Focus Area 1)

Garland Independent School District, (GISD), where 74.1% of students are economically disadvantaged, seeks funding for a Cybersecurity Summer Bridge Program. The program will increase the opportunity for 30 students from underrepresented populations to earn certifications or college credit.

In our cloud-based and hyper-connected world, the demand for cybersecurity professionals is rapidly increasing and expected to continue into the foreseeable future. According to Fortune Magazine, the number of unfilled cybersecurity roles worldwide grew 350% between 2013 and 2021, leaving exponentially more open positions than specialists needed to fill them. An identified gap for Garland ISD is the distinct disparity between workforce demand and student enrollment in the cybersecurity sector of the CTE program. Information Technology and STEM are the most in-demand career clusters in the Dallas-Fort Worth area, with 554 CTE learners. Per the Texas Workforce Commission, Information Technology ranks first in the Labor Market alone and twelfth in our school district, with only 162 CTE Learners enrolled in our current program. Overall, Information Technology is considered the least aligned program of study for CTE. The Garland ISD Summer Bridge Cybersecurity program is designed to increase these numbers while inspiring innovation, growth, and career pathway completion in STEM.

As with our previous successful efforts, we know the importance of broad-based understanding and ownership among our leadership team. Our decision to pursue 2022-2023 Summer CTE grant funds to support the design and launch of a Cybersecurity Summer Bridge Program was the result of multiple collaborative sessions among district leaders.

1b. Needs Assessment (Focus Area 2)

As the second-largest public school district in the Dallas-Fort Worth Metroplex, Garland ISD has 52,355 students enrolled, of which 74.1% are classified as economically disadvantaged. Funding would prove to be a catalyst for equitable student participation within Garland ISD boundaries.

This program would not only aid students in career exploration and obtaining a post-secondary education, it would drastically contribute to improving the rate of our nation's hospitality job market. According to a recent new member survey conducted by the American Hotel & Lodging Association (AHLA), the only national association representing all sectors of the U.S. lodging industry, 87% of survey participants indicated they are experiencing staffing shortages. As of August 2022, the U.S. Bureau of Labor Statistics reported that hotel employment was down by nearly 400,000 jobs compared to just two years ago. These staffing challenges are prompting reputable organizations like Omni Hotels & Resorts and the Texas Hotel and Lodging Association to raise awareness about the industry's plethora of opportunities, upward career mobility, and pay increases. Garland ISD aims to complement and continue these efforts through our Hospitality Project.

As with our previous successful efforts, we know the importance of broad-based understanding and ownership among our leadership team. Our decision to pursue 2022-2023 Summer CTE grant funds to support an immersive experience that will include career exploration in Lodging and Resort Management.
